

## Minutes of the Kimberley Nature Park Society Annual General Meeting for 2024

#### Meeting called to order at 7:08pm by President John Henly

## 8. President's Report for 2024–2025

- Sue Cairns is confirmed as official liaison from Kimberley City Council until September 30, 2026 (<u>Letter of Confirmation</u>)
- Strategic planning process: Through CBT Nonprofit Advisors program, we were able to work with Ingrid Liepa to help us assess the state of the organization, survey the community, and develop a strategic plan to guide our work
- Google Workspace: Graeme Donaldson set up a workspace so all directors have KNPS email addresses and we share file storage in Google Drive, where we can collaborate in documents
- Updated bylaws (see above)
- Procurement Policy: Created a straightforward document to guide purchasing decisions to ensure fair practices and avoid conflicts of interest
- Updating Management Plan: Jen McConnachie spearheaded a project to update and streamline this plan, which guides operations. It's in final revisions at this point and we hope to finish it up this spring.
- Hired Operations Manager: Anna Malvin started working with us in October as KNPS's first paid staff member. It's currently a 6-month contract but we hope to extend it permanently.
- Grants: We were awarded several grants in 2024 from CBT, RDEK, City of Kimberley, Province of BC

- New kiosk maps
- Wildlife Camera project: identifying wildlife using various areas of the park
- Trail counters deployed to track traffic on various trails
- Numerous guided walks: approximately monthly outings in different parts of the park, with different focuses (e.g., wildflowers, solstice, animal tracks). One outing led a group of students from COTR to introduce them to the park.
- New t-shirts for sale
- "Responsible Pet Owner" signage on Sunflower Hill to remind park users to prevent dogs from chasing deer and elk, especially during vulnerable times (winter and spring)
- Firewood Salvage Program: John recognized Andy Miller, who leads the program, which supplies firewood to local households. ~25 truckloads, ~150 volunteer hours.
- Working closely with Kimberley Fire Department on fire interface issues and fuel treatment programs. John thanked the members of the Fire Interface committee for their work on this issue, which is very important for the city.
- Built strong relationships with City staff
- Laura Duncan recently led a delegation to the City to ask about long-term funding to support KNPS's work, including Anna's position

#### 9. Plans for 2025

- HBV boardwalk replacement: RecSites and Trails BC has donated some money, and Anna will do a callout for volunteers in the spring
- Governance: We will pursue another CBT Nonprofit Advisors Program grant to focus on governance documents and organization
- KTS partnership agreement: clarify goals and overlap in operations
- Long-term grant application: Laura led delegation to city for this, to try to fund Anna's position
- Trail and Structure Assessment: inventory so we can plan a repair/replacement schedule for bridges, boardwalks, signage, etc.
- Conservation and ecosystem assessment: find existing data and define scope for this project to better understand the ecosystems in the area we manage
- Monthly newsletter: Anna emails out to the list (sign up on our website)
- Invasive species assessment: Dave Hale worked with EKISC to get a boot brush and signage at the Campground entrance, and we've also had weed pulls in the past. The plan is to assess the current status of invasives in the park so we know what to focus on.
- Education program with McKim: past partners at the schools have retired or moved on, but we'd like to resurrect this program to get kids (grades 6 and 7) out into the park, focusing on education and conservation, as well as citizen science. Several board members are putting together a plan for spring 2025.
- Responsible Use Agreement: common agreement for trail use organizations on how we use trails
- Community engagement plan
- Fundraising events: The first one will be a movie night on April 11. Stay tuned for more info.
